An Overview of the Problem

- Overdose is now the leading cause of death among Americans under 50 (New York Times)
- Marijuana contributes to psychosis, schizophrenia, reduces IQ in those who start smoking before 18 (SMART)
- One in four adults experiences mental illness in a given year (NAMI.org)
- Suicide is the 10th leading cause of death in the US (CDC, 2018)
- Eating disorders have the highest mortality rate of any mental illness

Affluent Families at Higher Risk?

- Higher rates of depression and anxiety
- Higher rates of substance abuse and addiction
- 66% of family businesses do not survive to pass down to the next generation, due in part, to addiction

Complicating Factors for Wealthy Families

- Money
- Isolation
- Social Pressure/Norms
- Parental Pressure/Achievement Pressure
- Status
- Lack of Purpose

"Specifically, affluent youth reported significantly higher levels of anxiety across several domains, greater depression, and significantly higher substance use than inner-city students, consistently indicating more frequent use of cigarettes, alcohol, marijuana, and other illicit drugs."




Mental Illness Among Affluent Families

- Wide array of mental illnesses affluent individuals and families
- No specific conditions unique to affluent individuals and families
- Wealth alone does not prevent mental illness

Implications on Treatment

- Access to treatment does not mean knowing the right treatment
- Wealth can allow mental health to go unaddressed and for treatment to be avoided
 - Insulates the natural consequences that sparks change in others
- Complex unregulated private-pay treatment industry



Mental Illness and Personality Disorders

- Mental Illness
 - Broad term encompassing many disorders and diagnoses related to mental and behavioral health
 - Personality disorders fall under the umbrella and are a form of mental illness
- Personality Disorders
 - Specific diagnoses highlighted by rigidity, unhealthy thinking, functioning, and behavior. Deep rooted disorders that effect a person's fundamental outlook on life
 - Examples include: Narcissistic Personality Disorder, Borderline Personality Disorder, Anti-Social Personality Disorder, etc.



Mental Illness and Substance Abuse Resources

- Leveraging existing treatment team network
- Utilizing Facilitated Family Meeting
- Understanding appropriate clinical interventions
- Referrals to Outside Coaches or Therapists for whole family system
- Utilization of multi-disciplinary teams

What is required of the family?

- Inclusion of family members
- Recognition of the problem
- Asking for outside help from qualified professionals
- Exposing feelings and addressing past issues
- Developing new coping skills
- Honesty and truthfulness
- Letting go of behavior that helps keep the person from feeling consequences



Advisors Initial Advice

- Behavioral health issues are chronic diseases. Require a long-term investment directed by a professional.
- Questionable practices in the behavioral health industry
 - Referral fees
 - False advertising on the internet.
- Professionals engaged in a situation should have expertise with the diagnosis (or diagnoses) of the client.
- Family and school involvement increases the long-term clients success.
- Achievement must be second to clinical stability.
